

I was born in Tororo district, Southeastern Uganda, with a family back ground similar to that of my brother Francis, Catholic. After high school I joined a teacher training college. After my qualification I taught in a high school, after which I married Daniel in 1992.

In 1993 I was trained in the city of Kusaka, Zambia in accelerated Christian College, and I got a diploma in Christian accelerated education. But because by that time Daniel was working full time with a Pentecostal denomination, I was forced to be in full time with that too. This was in 1995, so I had to resign from my teaching. During that time that pentecostal denomination was giving us all the necessary support.

In 2002 Daniel was sent for further training by that same denomination to America for six months where he was taught the true gospel by brother Dave Schmidt and brother Oscar Gavin in Fort Myers, Florida. When he came back to Uganda he carefully shared with me about the true gospel, and I understood him very well, and he baptized me, and I got converted to Christianity, because I was seeking for the truth alone from the Bible.

I got so excited that I had at last got the truth, I had to share the true gospel also carefully with my family members like brother Francis, sister Evelyn and the rest in our family. After I had made an effort to share with them this true gospel, by God's great grace they accepted to be baptized, and they too got converted into Christianity.

Daniel began the work of preaching this true gospel of our Lord Jesus Christ in 2003 in our home area in Tororo, and a good number of people accepted and got converted to Christianity, and the Church is there up to date. Then he also started work of the gospel in Kampala where we were living by then.

We received support from two congregations in America - namely Southside Church of Christ in Fort Myers, which gave us support for Church rent and for our upkeep. Meanwhile, brethren from the Laurel Canyon Church of Christ in Columbus, Ohio gave us support for house rent, which was \$400 us for quarterly payment.

In 2005 after Daniel knocked our own two year old son to death with a car. He first of all fled the country because of fear of Uganda police who wanted to arrest him for reckless driving. Later when he came back he looked confused and went away again. Up to now he does not communicate with us at all. I do not know whether he is still in Kenya or not, but our brethren from America stopped supporting us when Daniel fell off.

In 2006 my brother Francis started the work of preaching in this Jinja town where I live. I help him a lot particularly in evangelism and ministering to women and children.

At present only one sister from Southside Church of Christ has been touched to send to me between \$375 to \$400 per month. As God blesses my brother Francis, he also supports me as God also blesses him.

Otherwise I cannot go back to teaching because I have reached retirement age. My need is support for my house rent which is \$400 and upkeep which can be lowest \$1000. Kindly help me as God touches your hearts to do so through the compassion and mercy of our Lord Jesus Christ that he has put in his saints.
